**Selection of Designated ADA Coordinators** Subject:

Hafa Adai! In support of the Government of Guam's commitment to ensuring accessibility and compliance with the Americans with Disabilities Act (ADA), we are seeking qualified individuals to serve as Designated ADA Coordinators on a part-time or as-needed basis. These coordinators will play a vital role in overseeing ADA-related policies, assisting with accommodation, and ensuring your agency meets regulatory obligations.

#### **Role of ADA Coordinators**

Designated ADA Coordinators will be responsible for:

- Providing guidance on ADA compliance within the agency.
- Assisting with reasonable accommodation and accessibility concerns.
- Serving as a point of contact for employees, applicants, and stakeholders regarding ADA-related matters.
- Reviewing policies and procedures to ensure alignment with ADA regulations.
- Facilitating training to promote awareness and best practices in accessibility.
- Coordinating responses to ADA complaints and assisting in resolution efforts.

### **Selection Criteria**

Agency heads are encouraged to nominate individuals who possess the following qualifications:

- Knowledge of ADA regulations and disability rights to ensure compliance.
- Strong communication skills for effective engagement with employees, managers, and external parties.
- Problem-solving abilities to address accessibility challenges and provide practical solutions.

- Ability to work independently and manage ADA-related assignments with professionalism and confidentiality.
- Commitment to inclusivity and a proactive approach to accessibility improvements.
- Capacity to serve on a part-time or as-needed basis, providing flexibility to meet your agency's demands.

# **Designated Representatives**

Agency heads are requested to submit nominations by Friday, November 14, 2025, including:

- The nominee's full name and current position
- A brief statement outlining their qualifications and suitability for this role.
- Any relevant experience or competencies supporting their candidacy.
